## Disclaimer

Throughout the project, the RECIPES team engages with different stakeholders. Meetings are conducted to discuss issues related to precaution and innovation with citizens, workshops are organized to discuss the future of the precautionary principle and to develop tools and guidelines for its application, and stakeholders are interviews as part of the case studies on the precautionary principle.

As a basis for the selection of stakeholders for such exercises and for dissemination activities, a stakeholder database has been established as a living document that lists stakeholders. It is regularly updated, e.g. if new relevant stakeholders have been identified by the project team or have asked to participate in the project themselves.

The stakeholder database has been prepared by the different RECIPES partners, who researched and added stakeholders to an excel file based on their contacts, networks and addition research. However, no extensive research has been conducted to cover all relevant stakeholders across the EU.

The excel file is a living document that contains personal information such as contact details that are protected by the GDPR. Therefore, not all the information in the stakeholder database can be disclosed publicly. Still, there is an interest in understand how stakeholders have been engaged throughout the project.

To find a balance between data protection and transparency, the RECIPES team has prepared this document, a slim version of the stakeholder database. It list all the stakeholders listed in the database by providing the following information: (1) name of the organization, (2) type of stakeholder, and (3) country.
